### 1. Consent to Collection and Use of Personal Information

Snorkl (the “Company”) collects and uses personal information as follows:

- **Mandatory Collection and Use**

Purpose of Collection and Use	Account management, provision of the Snorkl platform and services, and improvement and personalization of the platform.
Period of Retention and Use	Unless required by applicable laws and regulations (such as the Act on Consumer Protection in Electronic Commerce), <b><u>the Company will retain your personal information until you withdraw from membership.</u></b>
Right to Refuse Consent	You may refuse the mandatory collection and use of personal information. However, refusal will prevent you from using the Snorkl services.
